Cookies

What are Cookies?

A cookie is a small text file that is stored on a user's web browser (e.g. Internet Explorer, Safari, Opera, Firefox, Chrome). Most websites you visit will use cookies in order to improve your user experience by enabling that website to remember users in order to store preferences, help users use the website more efficiently and to gather website analytics. How we use Cookies

Analytics
